



Required Documentation for VA Enrollment Certification

Chapter 33-Post 9/11 (Including transfer of benefits to dependents)

Required Information:

- FRCC Online VA Certification Request Form
- Certificate of Eligibility (COE) or e-Benefits document (**REQUIRED FOR PAYMENT HOLD**)
- 22-1995 (if transferring educational benefits to FRCC from another institution)
- All previous official transcripts and Transfer Credit Evaluation Request Form by 3rd semester at FRCC
- Degree/Certificate Change Form (if applicable)

**If there is not a COE, you will need to submit a 22-1990 (VONAPP) or a 22-1995 (if applicable)*

Optional:

- DD-214 (for residency purposes)

Chapter 30-Montgomery GI Bill

Required Information:

- FRCC Online VA Certification Request Form
- Certificate of Eligibility (COE) or e-Benefits Document
- 22-1995 (if transferring educational benefits to Front Range Community College from another institution)
- All previous official transcripts and Transfer Credit Evaluation Request Form by 3rd semester at Front Range Community College
- Degree/Certificate Change Form (if applicable)

**If there is not a COE, you will need to submit a 22-1990 (VONAPP) or a 22-1995 (if applicable)*

Optional:

- DD-214 (for residency purposes)

Chapter 35-Montgomery GI Bill for Dependents

Required Information:

- FRCC Online VA Certification Request Form
- Chapter 35 Supplemental Information Form (1st semester only)
- Certificate of Eligibility (COE)
- 22-5495 (if transferring educational benefits to Front Range Community College from another institution)
- All previous official transcripts and Transfer Credit Evaluation Form by 3rd semester at Front Range Community College
- Degree/Certificate change from (if applicable)

Optional:

- DD-214 of Veteran for SSN information and residency purposes (if eligible)

**If there is not a COE, you will need to submit a 22-1990 (VONAPP) or a 22-1995 (if applicable)*

Chapter 1606/1607-Reservists

Required Information:

- FRCC Online VA Certification Request Form
- Notice of Basic Eligibility (NOBE)
- 22-1995 (If transferring educational benefits to Front Range Community College from another institution)
- All previous official transcripts and Transfer Credit Evaluation Request Form by 3rd semester at Front Range Community College
- Degree/Certificate Change Form (if applicable)

**If there is not a NOBE, you will need to submit a 22-1990 (VONAPP) or a 22-1995 (if applicable)*

Optional:

- DD-214

Chapter 31-Vocational Rehabilitation

Required Information:

- FRCC Online VA Certification Request Form
- Vocational Rehabilitation Authorization Form 1905 (Submitted by VR Counselor)

Guest Students

Required Information:

- Front Range Community College Online VA Certification Request Form
- Parent Letter from Home School or Supplemental Enrollment Form
