



INTERNATIONAL STUDENT AFFIDAVIT OF FINANCIAL SUPPORT

Front Range Community College requires statements of financial support from all applicants for student (F-1) visas. You must have adequate financial resources to provide for your educational and living expenses without having to resort to unauthorized employment. FRCC must have verification of your financial resources. Affidavits of Financial Support and bank statements must be dated within six months prior to entering FRCC. The bank statements must be on the financial institution's letterhead and must indicate funds in U.S. dollars.

A Form I-20 will be issued only if we have assurance that you have full financial support for your proposed program of study at FRCC.
