Exemptions <ul style="list-style-type: none"> You can be exempt from the WP, EA and RC assessments if you have qualifying ACT (English 18, math 19, reading 17) or SAT scores (verbal 440 and math 460) from the last 5 years, possess an Associate of Arts or Associate of Science degree or a higher degree (BA, MA, PHD), or have completed college freshman English Composition and College Algebra with a C- or better.
